

## CHILI TOWN BOARD

April 17, 2013

A meeting of the Chili Town Board was held on April 17, 2013 at the Chili Town Hall, 3333 Chili Avenue, Rochester, New York 14624 at 7:00 p.m. The meeting was called to order by Supervisor David Dunning.

**PRESENT:** Councilman Brown, Councilwoman DiFlorio; Councilman Slattery, Councilwoman Sperr and Supervisor David Dunning.

**ALSO PRESENT:** Dawn Forte, Supervisor's Secretary; Sandra Hewlett, Stenographer; Virginia Ignatowski, Town Clerk; Daniel Knapp, Director of Finance; Ken Kraus, Deputy Town Supervisor; David Lindsay, Commissioner of Public Works/Highway Superintendent and Building Department Representative; Richard Stowe, Counsel for the Town; Eric Vail, Insurance Counselor.

This is a draft only and has not been filed according to Section 106 of the Public Officers Law. These are not certified verbatim minutes; they are a summary of the meeting. These minutes have not been approved by the Chili Town Board, and therefore, are subject to change.

The invocation was given by Virginia Ignatowski.

The Pledge of Allegiance was cited. The fire safety exits were identified for those present.

### **PRESENTATIONS/ANNOUNCEMENTS:**

#### 1. Presentation to Joseph Fulmore.

**SUPERVISOR DUNNING:** I would ask the Board if you could come down here. We do have a presentation to give this evening.

It's always nice to be able to recognize some of our finest citizens in the Town of Chili and everything that they do to contribute to such a great Town. I would like to -- this evening we would like to recognize Joseph Fulmore.

Joseph (Fulmore), would you like to come up?

I love your choice of colors today by the way. How are you?

Just so you know, there was an article in the Gates-Chili Post a little while back to kind of describe a little bit about what Joseph (Fulmore) has done, but Joseph (Fulmore) started a project, a gathering and giving away of toys. His initial goal, as I understand it, was to get and gather and give away 100 toys to, I believe, underprivileged and needy children; is that correct?

**MR. FULMORE:** Yes.

**SUPERVISOR DUNNING:** My understanding is he far exceeded that goal and he got over 1,000 toys, and in 2012 alone, over 200 toys were collected for that cause.

And Joseph (Fulmore), you know, on behalf of the Town of Chili and the Chili Town Board, we would like to congratulate you for this great accomplishment. It's a wonderful achievement. It's nice to see a young person getting involved and doing things for their community. As you know, it's a great benefit to those who receive these things and I'm sure it is well appreciated. We would like to offer you just a small token of our appreciation and a certificate of recognition. And the certificate says, "Joseph Fulmore, the Town of Chili recognizes and salutes the community outreach efforts of Joseph Fulmore for his continued dedication, commitment and support in helping others by collecting toys for the Ronald McDonald House. Your efforts are a source of strength to our community now and in the future. Presented the 17th day of April, 2013."

Joseph (Fulmore), thank you very much on behalf of all. (Applause.)

Would you like to say anything?

**MR. FULMORE:** (Inaudible).

Multiple comments were made amidst laughter.

**COUNCILWOMAN DI FLORIO:** Is this an ongoing effort?

**MR. FULMORE:** Yes.

**COUNCILWOMAN DI FLORIO:** Are you collecting for a specific time?

**MR. FULMORE:** Sometimes I start early. Sometimes I start in December. Depending on when I think I should start really.

**SUPERVISOR DUNNING:** Will you keep doing this?

**MR. FULMORE:** Yeah.

**COUNCILMAN SLATTERY:** Do your family members help you?

**MR. FULMORE:** They all do.

**SUPERVISOR DUNNING:** Well, you're certainly a great example to all of our people in the Town of Chili, especially our young people.

Thank you very much.

At this point, a Public Forum was conducted to allow public speakers to address the Town

Board. The following speakers addressed the Town Board on various subjects: Cary Lawson and Dorothy Borgus. The Public Forum concluded at 7:08 p.m.

SUPERVISOR DUNNING: I would like to say specifically to Mr. Lawson, thank you. It certainly means a lot to me, and I'm sure it does to this Board, as well as Ginny (Ignatowski), who was very much involved in getting this project up and running. And you will hear more about this hopefully on Saturday for those who will come out for the open house, but it was a long process. It was somewhat of a challenging and grueling process to get it done, but hearing from someone who is actually working in the facility now that you like this facility, you appreciate the facility and you approve of what was done, it does mean a lot to me.

And I won't speak for the Board, but seeing nodding heads, I'm seeing that they agree with that. So thank you very much for those comments. Appreciate it.

The rest of the questions were on resolutions, so I will get to those when we get to those resolutions.

#### **MATTERS OF THE SUPERVISOR:**

New Matters:

1. Vacancy Ethics Committee & BAR (Temp Member) Committee.

SUPERVISOR DUNNING: Just again, we have vacancies on our Ethics Committee and an opportunity on our Board of Assessment Review for a temporary member.

2. New Highway/DPW Open House 4/20/2013.

SUPERVISOR DUNNING: And again, we will have a -- hosting an open house on Saturday, this Saturday, from 10 a.m. to 1 p.m. over at the new highway facility. I encourage everyone to please come, stop out and visit. There will be some light refreshments there. We'll have some opening festivities, a ribbon-cutting and hopefully the weather will hold out good enough for us to do this all outside, but if not, we'll improvise and make do, but we hope to see everyone there.

3. Chili Art Show 4/26/2013 – 4/28/2013.

SUPERVISOR DUNNING: On the 26th through the 28th, the Chili Art Group has their art show right here in this room. Anybody who has not been to the art show, it really is -- it's a great showing of local works. They are mostly all Chili residents. I think the group put together, um, local artists that just get together and love to paint and do things. They do some remarkable work and they do display it here. Some of it is for sale. So I encourage people to come on out and visit the Chili Art Show during that weekend.

4. National Day of Prayer – Thursday, May 2, 2013.

SUPERVISOR DUNNING: Also coming up on May 2nd is the National Day of Prayer, and the Town has been very active with our local, um -- our spiritual leaders in the community get together and spend an hour together to -- this year "To Pray for America" is the theme, and again, I hope to see everyone out there for this -- this event.

COUNCILWOMAN SPERR: What church is that?

SUPERVISOR DUNNING: It's at Church Radiant, which is the old Carriage House over on Paul Road. Begins at 7 o'clock and usually winds up around 8 or thereabouts, depending on how long-winded we all get. But it a very, very nice event and I encourage people to come on out and show.

#### **MATTERS OF THE TOWN COUNCIL:**

COUNCILMAN SLATTERY: Yes, Supervisor, I would. I would like to thank Dave Lindsay, the Highway Superintendent, for having the crews go over to Union Square where there was graffiti spray-painted on the side walk, the street sign and fixing the damaged tree that was done by the vandals over there.

You know, I know there has been quite an effort, you know -- going over and taking care of that. I know there is a proposed development, and I'm not sure if it was the Town forces or he finally had his crews go out there and police that area and pick up the debris that has been scattered throughout there. So -- but as I know, it was mentioned at the Planning Board, you know, there were some issues.

But also, you know, there was the Sheriff's Department was over there again tonight, and they should set up a substation for the amount of times that they're over there. There was five cars actually in that area tonight. So it just speaks -- speaks to what has been ongoing out there and what the residents have had to deal with. But thank you for your crew and for what they have done helping to clean that up.

DAVID LINDSAY: I'll pass it on.

COUNCILMAN SLATTERY: I know there is some talk about the streetlights. Any

update on that for us?

DAVID LINDSAY: We talked a while back about extending the lighting district there and having them put in as part of the district. We also decided in light of this new project that is coming in, potential of the new project, we asked the developer to consider installing a portion of those lights as part of his project. He's indicated some agreement with doing that, so we're just going to kind of wait and see how far his project goes and get him to at least put in a portion of those.

COUNCILMAN SLATTERY: Okay. That would be great. I know the residents, speaking with them again, they would love to see that. I know Traffic & Safety reviewed this, as well, the street lights, and --

DAVID LINDSAY: The guys worked very hard over there today and the previous day trying to get the graffiti off the sidewalk. I will pass on your gratitude to them.

COUNCILMAN SLATTERY: Appreciate it.

COUNCILWOMAN DI FLORIO: I just wanted to give a bit of a follow-up. I know the Robotics Team was here last month, and they had -- the Churchville-Chili Robotics Team. They headed out to the Buckeye Regional with hopes of winning in that competition to go onto the championship out in St. Louis. Unfortunately, that did not happen.

They did, um, receive the Engineering Excellence and Industrial Service Awards out there. Made it to the quarter finales but did not make it into the championship.

But, um, one of the reasons I'm bringing this up tonight is because although they cannot go out as competitors, seven of the team members are, um, trying their best to get out there and actually go out and work as volunteers for the competition, and they have been working like crazy the last couple of weeks. Their advisors told them if they could raise the money, they could go out and volunteer. So they're doing cans, bottle drives, trying to earn the money to go out.

So if anybody is so inclined, you can get in touch with me or get in touch with somebody up at school and they will get you connected with the members of the team that are trying to do that.

I also -- the volunteering doesn't stop and the good news doesn't stop because if you haven't seen or heard, the team is also going to be featured in the USA weekend this Sunday for their mega drive that they did. They are being honored, three of the team members are going down to Washington next week and will be receiving a check for \$10,000 to be used, um, to -- to -- they're going to -- the money is to be designated to a charity. They have chosen to, um, use that money to start seed money to start other robotics teams in areas of the State that don't currently have them. So kudos to them, as well. We are very blessed in Churchville-Chili with our students.

COUNCILMAN SLATTERY: Any chance they could get some toys to help out with -- (Laughter.)

COUNCILWOMAN DI FLORIO: I'm sure they -- they would probably help do that.

COUNCILWOMAN SPERR: Just one comment. We had -- I have received many calls. As liaison to Traffic and Safety, I received many calls and questions from people about the light and the pole that is out at Archer and Ballantyne.

I know we have been talking to David Lindsay who has been communicating with the State. We have been waiting for the State to complete their work on that. I wondered if you could give us an update. I haven't had a chance to drive down there. Did they actually get that started this week or not yet?

SUPERVISOR DUNNING: No.

MR. LINDSAY: I don't believe they started this week. The last I spoke with the DOT they're waiting for what is called stakeout there. The contractor had to have a pole specially manufactured for that site. He anticipated they would be starting this week out there. I will keep an eye on it and reach out to the State if I don't see something happening by Friday.

SUPERVISOR DUNNING: They put out some orange barrels right now, so that is as far as anybody has gotten with it.

COUNCILMAN SLATTERY: They put them out or the wind blew them there.

SUPERVISOR DUNNING: It could be either/or, but there are orange barrels there now around -- around the spot.

COUNCILWOMAN SPERR: The only other comment I had, too, I was at a leadership series event at Roberts Wesleyan Friday morning. This wonderful gentleman, Miles, came up to me and just wanted to pull me aside and brag about how great our Highway Department is. So, Cary (Lawson), I'm glad you're here tonight because Miles was just raving, and he used to live over in the Red Bud area which was heavily laden with leaves and trees, and he was just raving -- he actually pulled me aside. The only thing he wanted to tell me. So I just wanted to pass along the good word. Thanks again for your nice comments and for taking the time to tell us.

**TOWN BOARD DISCUSSION RELATED TO THE FOLLOWING RESOLUTION:**

**SUPERVISOR DUNNING:** The question was when will this start and what is the process? Well, um, first the Town of Wheatland also has to pass a resolution to accept Labella as their consultant. The next moves will be the Town of Wheatland and the Town of Chili will meet with the consultant to firm up a contract.

After that, both towns will select a Steering Committee to work with the consultants on this. That -- when we do that, affirmation will be made public so we can have the public's input on who would like to be a part of that Selection Committee.

I will share that we have discussed the people we would like to see involved in that Selection Committee, and that being certainly, we want farmers involved in that. We would also like to have major stakeholders, land holders who may not be farming their property but leasing it to someone who does. We would like some of those people involved.

As well as residents who have no interests -- no specific interest in farming -- that's a tough one.

COUNCILWOMAN DI FLORIO: Vested interest.

SUPERVISOR DUNNING: Thank you.

Who have no vested interest in the farming operations but may have some interest in this plan.

So we going to put together a Committee. There will be representation from both towns, and then we'll basically take it from there.

So when will all this start? It can't start until after Wheatland -- Wheatland has their Town Board meeting tomorrow night and if they approve and adopt this resolution, we'll likely meet within the next week or two with Labella to firm up a contract and then start the selection process. So we're probably a few weeks out before we -- at least a few weeks out before we get into that process.

COUNCILWOMAN SPERR: Do we have to pass a resolution for the people on Committee?

SUPERVISOR DUNNING: No.

COUNCILWOMAN SPERR: We don't?

SUPERVISOR DUNNING: No.

COUNCILWOMAN SPERR: I didn't think so.

SUPERVISOR DUNNING: That information will be shared with everyone.

COUNCILWOMAN SPERR: Right.

**RESOLUTION #146 RE: Towns of Chili / Wheatland Farmland Protection Plan Consultant**

**OFFERED BY: Councilwoman Sperr      SECONDED BY: Councilwoman DiFlorio**

**WHEREAS**, the Town of Chili as lead agency and Town of Wheatland have received a farmland protection grant from the Department of Agriculture and Markets; and

TOWN BOARD DISCUSSION RELATED TO THE FOLLOWING RESOLUTION:

SUPERVISOR DUNNING: There was a question on this. This was an error that I made when we approved our budget. We approved it for an amount greater than what we actually ended up putting in our budget. When we went through our budget workshops and made the decisions for the Fire Departments, um, the amount of money the Fire Department was going to get, we all agreed and put down a number, and for some reason when I transposed that into our budget, it was \$21,246 less than it was initially. So that was an error that I made in transposing the numbers from our agreements, initial agreements into the actual penned document. So we are making that up now.

TOWN BOARD DISCUSSION RELATED TO THE FOLLOWING RESOLUTION:

SUPERVISOR DUNNING: Basically there was a question on the abstract possess. I guess I'll answer it at this point in time. Each and every -- before the abstract is paid, before we pay the bills, this specific resolution that you see in front of you as well as -- as an -- as well as the complete abstract is given to each one of the Counsel members to review.

Um, over a period of several days -- it takes you though several days before -- before -- Councilman Slattery is showing me his right now. Each one of us gets that to review. We then have a signator list that goes with each one of those -- with that resolution. Until at least a minimum of three signatures are secured, we do not pay the bills. So -- each one of us would sign off on that resolution, and, um, give that to the Director of Finance who then -- then we start the process of paying bills.
