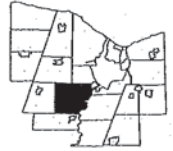

The person requesting a copy of a marriage license must be:

- One of the applicants
- Power of Attorney with Proper Documentation
- Representative of government agency
- A relative of the couple whose marriage is more that fifty years old and both parties are known to be deceased
- An attorney representing either party with papers from applicant

**FEES:** There is a \$10.00 charge for each copy requested.
