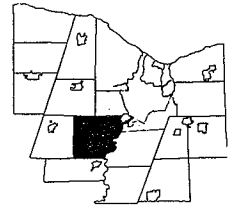

Meeting called to order by Chairman Fred Trott at 7:00P.M.
Minutes of the October meeting were approved.

OLD BUSINESS 7/6/06

Item # 4 Traffic is backing up on Rt. 259 past Rt. 490 exit from Chili Ave., reported by committee members the problem continues, mini gridlocks. The intersection continues to be a hazard. What is the schedule for the permanent fix to the problem? **State to widen road for 2 lanes for southbound traffic, one lane for turns (no signal upgrade). M. Sperr will get together with Senator Alesi and ask for additional state funding for improvements. M. Sperr and D. Lindsay met with Kevin O'Buckley from NYSDOT. F. Trott to email D. Lindsay to check on progress. The MCSO with conjunction with the NYSDOT recognize that using the sholder of the road to pass a vechicle turning left is within the law and the current traffic flow.**

OLD BUSINESS 10/4/07

Item # 2 Barb Denigris of 254 Archer Rd representing the residents are concerned about safety as current speeds are in excess of the 30mph. **Committee will continue to monitor, and the towns' temporary signs were used. The Monroe County Sheriff has increased patrols.**

OLD BUSINESS 2/7/08

- Item # 2 Committee reviewed plans for a 66 room motel by Microtel behind Valvoline and the Bank of Castile on Chili Ave. The committee had some concerns:
- a – size of road width and radius of curve
 - b – Traffic around building, road needs to be 26 feet wide.
 - c – fire access on plan with front parking only
 - d – Committee would like to see a traffic study on the need for traffic light at The intersection of Old Scottsville Road and Chili Ave.
- Committee reviewed updated plans and is satisfied with the new changes.**

OLD BUSINESS 2/7/08

- Item # 3 Railroad tracks on Paul Rd. near Beahan Rd. are very rough. **Full repair to done the summer of 2009.**

OLD BUSINESS 8/7/08

- Item # 3 Request for speed bumps on Evergreen. **F. Trott to sent an email to Monroe County Sheriff Lt. Clar.**
- FYI At the intersection of Morgan Rd and Union St. the bushes are growing out to the road. The bushes need to be trimmed. **D. Lindsay has contacted the home owner about trimming the bushes.**

OLD BUSINESS 9/4/08

- Item # 1 Crosswalk over the railroad tracks on Old Scottsville road are warn off. **D. Lindsay will install “Thermal Strips” for new crosswalk markings.**

OLD BUSINESS 10/2/08

- Item # 1 Median at entrance into Wegmans from Paul Rd. needs to be painted to designate the entrance and exit.
- Item # 3 Speeding on Emerald Point Rd. **Committee to investigate.**

NEW BUSINESS 11/6/08

- Item # 1 Request for a “No Outlet” sign on Keubler Dr. **Committee to investigate.**
- Item # 2 Request for a “Do Not Block Driveway” sign for 94 Archer Rd. **Committee to investigate.**

NEW BUSINESS 11/6/08

- Item # 3 Charlie Rettig expressed concern about parking on the shoulder of Buffalo Rd. west of Hubbard Rd. on the north side of Buffalo Rd. near the Heritage House. **Committee to investigate.**
- Item # 4 G. Barnett express concern about some low hanging wires and the poles that the wires are attached to, at the location of the proposed Microtel Hotel. The poles need some protection around them to prevent them from being hit.
- FYI The town has purchased 25 fluorescent "Slow Down markers" that will be installed on the post holding current speed limit signs. **The committee will recommend as to where they should be installed.**

Comments to Planning Board

OLD BUSINESS:

1.-3. Application of Indus Real Estate LLC, 1170 Pittsford Victor Road, Pittsford, New York 14534, property owner: Chili Avenue Associates; for preliminary subdivision approval of one lot into two lots in the Faber Homes Subdivision at property located at 3260 Chili Avenue in G.B. zone. Committee reviewed plans for a 66 room motel by Microtel behind Valvoline and the Bank of Castile on Chili Ave.

Our Committee reviewed updated plans and is satisfied with the new changes. We would like to express concerns about some low hanging wires and the poles that the wires are attached to noted at the location of the proposed Microtel Hotel.

The poles may need some protection around them to prevent them from being hit.

PUBLIC HEARINGS:

1.-2. Application of Aldo Lepore, owner; 3210 Chili Avenue, Rochester, New York 14624 for resubdivision approval of two lots in the Village Park and Lepore Subdivisions at properties located at 3218 Chili Avenue and 849 Paul Road in G.B. Zone.

Our committee likes that the owner will make available access from Chili Village to their business. We feel this will reduce traffic on Chili Ave. Our committee hopes that the owner will still use existing speed bumps.

3. Application of Louis Ribero, 1145 Channing Woods Drive, Webster, New York 14580, property owner: B & R Realty; for preliminary site plan approval for a change of use in portion of building to allow business offices (retail/restaurant approved) at property located at 1302 Scottsville Road in G.B. Zone.

Committee has no comment.

4. Application of Heritage Christian Services, owner; 349 W. Commercial Street, Suite 2795, East Rochester, New York 14445 for final subdivision approval of three lots to be known as Heritage Westside Subdivision at property located at 1125 Westside Drive in R-1-12 zone.

It was noted by a resident that Heritage workers are parking on Buffalo Rd at that Heritage house. We would recommend that the owner mention this to employees that this may cause a dangerous situation.

INFORMAL:

1. Application of Wegmans Food Markets, P.O. Box 30844, Rochester, New York 14624 for final site plan approval to erect a 4 story office building addition totaling 400,000 sq. ft. and 2- one story additions totaling 2,552 sq. ft. at property located at 249 Fisher Road in L.I. zone. **Committee has no comment.**

2. New Hope Community Church, 3355 Union Street, North Chili, New York 14514 for approval of building elevation changes to addition that was granted site plan approval in 1997. **Committee has no comment.**
