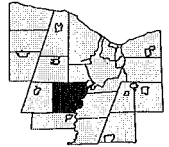

To Whom It May Concern:

The Town of Chili Building Department is now issuing plumbing licenses for the year 2017. If you wish to renew your license, please fill out the enclosed application form and send in with the license fee. A one-year license is \$75.00; a two-year license is \$100.00. Licenses are issued per calendar year. Please make check payable to Virginia Ignatowski, Town Clerk, but mail application to the Building Department.

Along with the application form and fee, you will also need to send a current Certificate of Insurance for both General Liability and Worker's Compensation with the Town of Chili listed as Certificate Holder. If you are self-employed and do not carry Worker's Compensation, there is a form that needs to be filled out. Effective December 1, 2008 you need to fill out the Form CE-200 for every permit/license issued (one form to obtain your license, and then one form for each address of a plumbing permit being issued). This form can be downloaded by going to www.wcb.state.ny.us and under the heading "forms. Once you have filled in the information, you will then print out the form, which will have a certificate number on the bottom left hand corner. Please bring in that form with each permit application. **Please note that for contractors who do carry workman's compensation, we will not accept the Worker's Compensation Certificate on the Accord form. It must be on the approved State Worker's Compensation Form (C-105.2 or U-26.3, or for self insurance, form SI-12 or GSI-105.2).** Those forms are good for the standard one year and can be used for multiple jobs.

If you wish to authorize persons other than yourself to pick up plumbing permits under your plumbing license for the year 2017 (and 2018 if applying for a two-year license), please complete the plumbing permit authorization form which is also enclosed and return with your license fee, application, and certificate of insurance.

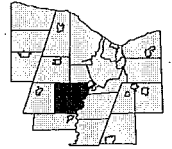

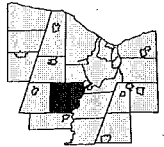
