

CHILI TOWN BOARD  
January 22, 2014

A meeting of the Chili Town Board was held on January 22, 2014 at the Chili Town Hall, 3333 Chili Avenue, Rochester, New York 14624 at 7:00 p.m. The meeting was called to order by Supervisor David Dunning.

PRESENT: Councilman Brown, Councilwoman DiFlorio; Councilman Slattery, Councilwoman Sperr and Supervisor David Dunning.

SUPERVISOR DUNNING: We do have two presentations this evening. I would ask the Town Board if you would like to join me down here, as well as Mr. Lindsay, if you would.

One of the best parts of what I do is to recognize our employees from time to time, and we have really -- this -- one them almost was here longer than I am old, but --

COUNCILWOMAN SPERR: You like that one, Larry (Mobilio)?

SUPERVISOR DUNNING: But it is really an amazing career. They have done a phenomenal job for the Town of Chili. Always represented us very well out in the public, and they're part of the team that -- most people when you drive around Chili, um, you take a look at our roads and some of the conditions around the Town, some of the things that the drainage and other things that happened here, and both of these gentlemen are responsible for that reputation that the Town has received for -- for that great work.

And they're part of a great team. So tonight we are going to -- we would like to honor two gentlemen.

First, Larry Mobilio. And, Larry (Mobilio), I would like you to join us if you would, and also Dennis Gibbs. Larry (Mobilio) served the Town of Chili for 40 years, which is -- just unbelievable. You don't even look that old, Larry (Mobilio).

And Dennis (Gibbs) has been for 33 years, and that time has -- is just incredible. You don't see that a lot any more. People tend to move around. But just goes to show the Town of Chili is a great place to work for. It's you guys that help make that.

So I would like to thank you for your service. I will turn it over to Mr. Lindsay to present your awards here, but small token of our appreciation for everything you have done. I realize -- wish we could do a lot more for you, but we appreciate everything have you done for us for 40 years and 33 years.

DAVID LINDSAY: Supervisor, certainly it is difficult to do justice to the years of service you have given for this community. Dennis (Gibbs), I believe you started in September of 1980. And Larry (Mobilio) you started in April of 1973. That is 33 plus years for you and 41 -- and I believe this year will be your 41st year of service.

That speaks well to your professionalism, your commitment and dedication to this community. I have had the -- I have had the honor to work you guys for the last six years. I know you took pride in the work that you did and the high quality service for the residents of the community.

As Supervisor said, Chili has some of the best -- the best maintained roads in the County and that is due in no small part to the skill, the knowledge and talent of men like yourselves.

I know that over the last three or four decades you spent many long nights working, missed many special events and holidays with your family and many weekends on the job, and I want you to know it has certainly not gone unnoticed or unappreciated.

So on behalf of the Town of Chili and its residents, I'd like to give thanks and appreciation for your dedication and commitment to this community, and I wish you well in your retirement. And hopefully on a day like today, you can look out the snow and -- (Laughter.)

**MATTERS OF THE SUPERVISOR:**

Pending Matters:

1. Vacancy Drainage Committee, Ethics Committee, BAR (Temp Member) Committee.

SUPERVISOR DUNNING: Just to let everyone know, we still do have vacancies on the Drainage Committee, Ethics Committee and for a temporary member of the Board of Assessment Review. I think that pretty much covers all of the committees, if I'm not mistaken that have vacancies.

Just a reminder that Monday night, the 27th, there will be a public meeting for the Farmland Protection Plan. That is a joint plan between the Town of Chili and the Town of Wheatland. That will be held at the American Legion on Scottsville -- or the corner of Chili Scottsville Road and Stryker Road. It's a public meeting, 7 p.m. Anyone who wishes to be there, it would be a pretty good place to catch up where we are with our Farmland Protection Plan right now.

**MATTERS OF TOWN COUNCIL:**

COUNCILMAN SLATTERY: Supervisor, if I could, I know the gentlemen just stepped out, but I had the opportunity and pleasure to work with them. I think one thing that I like to mention is the experience, the knowledge, the history. When there are problems coming in, whether in the middle of the night, during the day or whatever, their knowledge of past history of what took place, um, problem locations and so forth, I think that's something that is going to be missed, and it's hard to just over the years try to pass that along to others, but, you know, they -- they did a fabulous job.

When I -- working with Dave Lindsay and I had the pleasure this year working with Larry Mobilio and other Town staff on a couple County roads. You know, they came out, they knew what had to be done. You don't have to sit there with them. They're going take care of it. You can go onto another task and come back and, you know, it's -- they did a fine job. So we -- we're proud to have them, and so I just wanted to pass that along.

SUPERVISOR DUNNING: Great.

COUNCILWOMAN SPERR: If I could add a little bit to what Councilman Slattery said, the last couple, two, three weeks we had some snowstorms here in Town. And when you have to get someplace, driving was hazardous. But I have to tell you, even this morning I had to drive through the Town of Chili, in through the Town of Gates and into the City and I knew exactly when I left the Town of Chili. So I just wanted to say hats off to everybody that works hard to keep our roads plowed and salted and safe for us to drive on. I just wanted to make sure that I commend our department. When they work hard, I want people to notice and let them know we appreciate it. I really do.

COUNCILWOMAN SPERR: Yes, I did.

SUPERVISOR DUNNING: I get that a lot. I get those phone calls a lot.

COUNCILWOMAN SPERR: I'm not picking on Gates. I will get --

SUPERVISOR DUNNING: Gates, Ogden, Riga, it doesn't matter. (Laughter.)

COUNCILWOMAN DI FLORIO: Any Town that borders our Town.

Um, I did have one separate note. Well, two things.

Um, on the agenda you see Tom's resignation -- Venniuro's resignation, and I just wanted to just point out he's going to be sadly missed in the Recreation Department. He has brought a lot of energy and new programming to the Town, so he's going to be sorely missed.

COUNCILMAN SLATTERY: Supervisor, if I could to Dave Lindsay, do you know the turnaround time for this, when you anticipate possibly receiving this?

DAVID LINDSAY: The bid you mean?

Partially when we went through the process of the -- the requirement of the process to select a consultant, um, prohibited us from looking at the dollar amount. The -- the money that was committed both by grant and the Town had already committed through the RFP, was a maximum amount of money. We'll get to what that is in a minute here. The reason it's not on here, I didn't know it. I didn't know. I never opened up the dollar amount myself.

Now, Mr. Lindsay, you might be able to share at this point what that dollar amount was, but that is why it never made the agenda. Because I didn't know the dollar amount, because at that time I wasn't supposed to.

DAVID LINDSAY: We did not open up the envelopes that contained the dollar amounts for the various consultants that bid on this project that submitted RFQs. It was a qualification-based selection.

Once we made that selection, then we opened up the bid proposal from the consultant firm that we selected to make sure it didn't exceed the funds allowed or provided in the grant, which it doesn't. I think it's -- not exactly, but like 66,400 or something like that, so it is below the grant amount.
