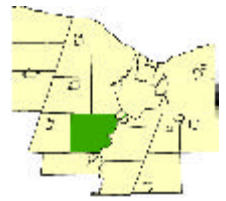

4. A brief history of the Historic Preservation Board

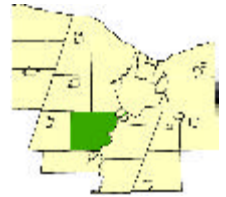

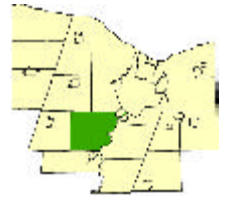

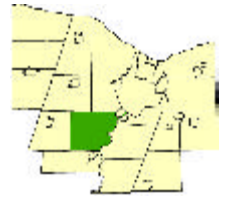
