CHILI TOWN BOARD February 9, 2022

A regular meeting of the Chili Town Board was held on February 9, 2022 at the Chili Town Hall, 3333 Chili Avenue, Rochester, New York 14624 at 7:00 p.m. The meeting was called to order by Supervisor David Dunning.

The invocation was given by Virginia Ignatowski.

The Pledge of Allegiance was cited. The fire safety exits were identified for those present.

SUPERVISOR DUNNING: Going to go off schedule here just a little bit. I know it's not on the agenda, but we have something very important to do before we get going with the rest of our meeting. Mr. Stowe.

For anybody here that doesn't know, this is Rich Stowe. He was our Counsel for the Town for many, many years. And we would like to present you with a small token of our appreciation. Of course, your name plaque that sat up on that dais for — it looks like — for 33 years.

RICHARD STOWE: Not that long.

SUPERVISOR DUNNING: Not that long.

But anyways, this is -- we also have an engraved Certificate of Appreciation for Rich (Stowe). I would like to read this in its entirety, this Certificate of Appreciation.

"This Certificate is awarded to Richard E. Stowe for your 33 years of service to the Town of Chili. We are extremely grateful. You have served the Town with the highest levels of integrity, ethics and professionalism. Your wisdom and knowledge cannot be replaced. It has been an honor and a privilege to have you just not as our Counselor of our Town, however, a valued friend. Our sincerest wishes for happiness in whatever your future looks like and holds for you."

Mr. Stowe, from me, we have worked together for a long time. And -- we had some interesting conversations. You taught me a lot. You have helped me not only with the Town business, but the right way things should be done in the Town. I know oftentimes I would come and -- this is really what I would like to happen, but you were so diligent in making sure that it was the right way and not necessarily the way I wanted to get it done. And that I appreciate. Because I think had it not been for you and your guidance and support that you have given me over the years, I probably wouldn't have been as successful here in the Town of Chili as I have been. So -- so for that I am extremely grateful.

On behalf of myself and the Town Board, I want to -- hope you will hang this somewhere -- RICHARD STOWE: We have a spot for that.

SUPERVISOR DUNNING: -- whether it's in the office or at home. We hope you will hang this and remember us always.

And I will always remember that phone number, so you're not completely off the hook. But I will always remember that number.

So again, thank you for everything you have done. I appreciate it.

RICHARD STOWE: Thank you.

For the last several years he has been smart enough to allow that to happen. Haven't you?

SUPERVISOR DUNNING: What is that?

RICHARD STOWE: Me to speak.

COUNCILMAN SLATTERY: You want to ask your wife?

RICHARD STOWE: Unless spoken to.

SUPERVISOR DUNNING: Yes. I have learned from the best.

RICHARD STOWE: One of the things I did learn was that -- and Jared (Hirt) may see the wisdom in this, as well. It is often smarter not to say anything than to speak when what you want to say may not be exactly what everybody needs to hear at that point in time.

I appreciate this. I appreciate the opportunity to serve. I did the math the other day and this is almost half of my life. Almost.

SUPERVISOR DUNNING: Close enough.

RICHARD STOWE: But it truly has been an honor and a privilege and I have worked with a lot of great people in this Town and it truly has been a privilege. It's -- it has been an interesting journey. Any

of you that have had the opportunity to work with a lot of really great people -- and what you come to understand is that everybody has the Town's best interest at heart. And it may not always seem like it when Sandy (Hewlett) and I are sitting here at 1:30 in the morning with meetings that don't seem like they're anything close to productive, but at the end of the day, I truly believe that everybody really wanted to make the Town a better place and it's an honor to be able to help. So thank you. (Applause.)

SUPERVISOR DUNNING: You are forever part of the Chili family here. Forever. You will never be relieved of that. You are welcome here for anything that we do here. You are and -- are welcome to be part of it and I hope you will be.

RICHARD STOWE: The -- the phone number is always available.

SUPERVISOR DUNNING: I know that number.

RICHARD STOWE: I know you do. I know you do. But if there is ever anything that we can do to help, please call. The desire to help is still there.

SUPERVISOR DUNNING: Thank you. Thank you for everything. COUNCILMAN SLATTERY: David (Dunning), if I can real quick.

RICHARD STOWE: Oh, God no.

COUNCILMAN SLATTERY: My condolences to your wife now you will be home a little more.

RICHARD STOWE: I'm not home anymore.

SUPERVISOR DUNNING: Or any less.

RICHARD STOWE: Or any less.

COUNCILMAN SLATTERY: For the number of years I have been on the Town Board and working with you and just being able to look down the dais and just see you when something is being discussed, watching your eyes, watching your expression to say, "Okay. Back up. Go forward. Oh, you said too much."

Just looking at your eyes and just seeing that and -- or -- like a sign language ability. Or when we go into Executive Session and you bring in that calmness, you bring in that demeanor that is saying, "Okay. This is what we're looking at. This is what we should be thinking about," and not -- not telling us what to do, but just, "This is the law. This is what you should be aware of."

And it put us in such a better place. And it just made us feel so much better. Even the people on the Side Table, I know they appreciate that, as well. But thank you so much. Personally and professionally.

RICHARD STOWE: Thank you. That's very kind. And the -- the only other thing that is sort of obvious -- kids call me "Captain Obvious" -- but there's a long tradition in our family of serving. There's great-grandparents that were Supervisors in this Town.

This building is on property that my grandparents used to own.

So it's -- it goes both ways. It's -- it's an honor to be able to serve. It's -- it's a privilege to be able to pass it on and we hope it can continue.

SUPERVISOR DUNNING: The Stowe name will forever live in the Town of Chili. (Applause.) VIRGINIA IGNATOWSKI: I used to come to those Town Board meetings that came to 1:30 in the morning.

RICHARD STOWE: Yes, you did. You were part of the problem. (Laughter.) A photograph was taken.
