COMMENTS OR QUESTIONS FROM THE AUDIENCE:

DOROTHY BORGUS, 31 Stuart Road

MS. BORGUS: Dorothy Borgus, 31 Stuart Road. What is the incentive?

SUPERVISOR DUNNING: I believe it was 40,000.

MS. BORGUS: It's?

SUPERVISOR DUNNING: \$40,000 cash to be put into a reserve fund. We haven't made a complete decision. I think it was either the Sidewalk Fund or Parks and Recreation Fund.

MS. BORGUS: Thank you.

LINDA SCHMALFUSS, 35 Attridge Road

MS. SCHMALFUSS: Good evening, thanks for the opportunity. Linda Schmalfuss, 35 Attridge Road.

On June 14th, you, the Town Board, passed the rezoning of 4415 and 4423. On June 19th, I delivered a letter to –

JARED HIRT: Excuse me.

SUPERVISOR DUNNING: Ms. Schmalfuss, this is for the -- this is for 50 Air Park Drive.

MS. SCHMALFUSS: Oh.

SUPERVISOR DUNNING: This is not about 4415 or anything on Buffalo Road. This is for the property at 50 Air Park Drive.

MS. SCHMALFUSS: At another time | get to speak?

SUPERVISOR DUNNING: You may at a -- at the Public Forum, sure.

MS. SCHMALFUSS: Right now this is not it?

SUPERVISOR DUNNING: Right. Correct. The Public Forum would be next if you wish to speak at the Public Forum.

The public hearing was closed at 7:03 p.m.

SUPERVISOR DUNNING: I'll quickly respond to the fitness resolution, Dorothy (Borgus). Those are both for young and old. They can be for you as well as –

COUNCILWOMAN SPERR: For me?

SUPERVISOR DUNNING: -- grandchildren.

No. I'm talking about younger, much younger.

Grandchildren or -- it's for all generations who would be capable of using -

MS. BORGUS: Exercising?

SUPERVISOR DUNNING: Yes. So it is for everybody.

MATTERS OF THE SUPERVISOR:

SUPERVISOR DUNNING: Under Matters of the Supervisor, I would like the Town Board to know that I received notice from the ARC of Monroe that they do -- they do plan on a group home that they're looking at at 31 Hitree. They are looking at this. We have 40 days to respond or appeal to their decision to build a group home.

Looking at typically the grounds for -- to reject their group home, we have no grounds, as it is, by law to reject it. There is no density issues in the area. There is no -- there is nothing in the area that would allow us to -- to reject their -- the group home. But I will get you a copy of this to look at it. We'll have time to respond.

COUNCILMAN SLATTERY: Supervisor, in regards to that, you said to build a group home or to modify an existing home?

SUPERVISOR DUNNING: Thank you. It is to modify an existing home.

COUNCILWOMAN SPERR: But also the good he did for the community through his work at Lifetime Assistance. What he was able to accomplish over there. He has contributed in such a major way to the success that they have achieved. He was just -- just a really great guy.

I know we haven't seen much of him lately because he was sick, but we're all going to miss him. COUNCILMAN SLATTERY: Actually, Mary (Sperr), I'm glad you mentioned it. The first time I met him when I was elected to the Town Board -- during the Chil-E Fest when we used to have rides at the event, on that Thursday we would bring out individuals with special needs. They would ride the rides for free on that Thursday and that's when I met Jordon (Brown), when the group -- the group from Lifetime Assistance. All these vans showed up and all these individuals and just taking them around to the rides. That was the first time that I actually met Jordon (Brown) was during that time.

COUNCILWOMAN SPERR: Good guy.

TOWN BOARD DISCUSSION RELATED TO THE FOLLOWING RESOLUTION:

SUPERVISOR DUNNING: Question from Dorothy (Borgus) on the material. That's a good question. At this point, Dorothy (Borgus), the current -- what we have -- the current quote is for aluminum. We're actually questioning whether or not that's what we really need.

Mr. Lindsay is going to be working with some other folks and talking about possible -- you know - right now it's vinyl and it is said that vinyl over time cracks and we do know that the soffits from time to time fall down. They have done quite a few replacements.

This is needed. Now we have a nice, new roof. This building will probably be pretty well set for about 50 years or better. So –

COUNCILMAN SLATTERY: Outlive -

SUPERVISOR DUNNING: It will outlive all of us in this room right now. So we are doing some due diligence on this side.

Yes, you, too, Adam (Cummings).

ADAM CUMMINGS: I'm going to beat it.

COUNCILMAN SLATTERY: Sir, no comments from the audience. (Laughter)

SUPERVISOR DUNNING: We're not sure exactly what material this will be at this point but likely aluminum or vinyl.

BE IT FURTHER RESOLVED, the Supervisor of the Town of Chili, is hereby authorized to execute, on behalf of the Town of Chili, all necessary documents in furtherance of this resolution subject to review and approval of the Counsel for the Town.
