Local Law no. 3 of the year 2023

A local law Establishing a Temporary Moratorium on Smoke & Vape Shops Within the Town of Chili.

Be it enacted by the Town Board of the Town of Chili as follows:

SECTION 1. TITLE

This Local Law shall be known as the "Moratorium on Smoke & Vape Shops within the Town of Chili."

SECTION 2. STATUTORY AUTHORITY; PURPOSE AND INTENT.

- 1. There is a substantial likelihood of the establishment, operation and expansion of smoke shops, tobacco stores, vape shops and stores that are dedicated to the retail sale of tobacco and tobacco related products/paraphernalia, nicotine and nicotine related products/paraphernalia, vape related products, e-cigarettes, e-vaporizers, waterpipes, electronic nicotine delivery systems, hookahs, pipes, bongs and similar manufactured devices used for holding burning material ("Smoke and Vape Shops").
- 2. The Town of Chili has determined that the establishment, operation and expansion of Smoke and Vape Shops in the Town of Chili will result in undesirable changes to the community, including, but not limited to, increased potential for sales to minors, greater opportunity for the sale of illegal drug paraphernalia that is marketed as tobacco paraphernalia, the heightened risk of negative aesthetic impacts, blight and the loss of property values of residential neighborhoods and businesses in close proximity to Smoke and Vape Shops.

- 3. The current Zoning Code for the Town of Chili does not have specific regulations and provisions applicable to Smoke and Vape Shops.
- 4. The Town of Chili has determined that the regulation of Smoke and Vape Shops is necessary and in the interest of the public health, safety and general welfare of the community and the residents of the Town of Chili.
- 5. The Town of Chili has therefore concluded that it is proper and warranted to impose a six (6) month temporary moratorium: (a) on the issuance of all new building permits, certificates of occupancy/compliance and land use approvals for the construction, establishment and operation of new Smoke and Vape Shops in the Town of Chili; and (b) on the issuance of all new building permits, certificates of occupancy/compliance and land use approvals for the expansion of existing Smoke and Vape Shops in the Town of Chili. Said moratorium will provide the Town of Chili with time to review and consider potential zoning changes and amendments to the Town Code and to otherwise consider specific regulations for Smoke and Vape Shops.
