Larry Lazenby announced that, The Town of Chili Tree Planting Policy has been approved and adopted on February 14, 2024. Three trees are scheduled to be planted this year. The policy will last for 5 years and will then be subject to review and renewal.

Larry inquired about communities with only one waste hauler. There are some downside concerns for this arrangement. Generally, a multiyear contract is required, with possible unseen cost increases.

to be known as Vista Villa Phase 2 at 100 Club House Drive. PRD District

Preliminary Sub-division approval.

This proposal is non applicable to the Conservation Board currently. This is only a sub-division of land proposal. The Black Creek flood plain is shown.

Landscape plans are included in the design plans set. These show 56 street tree plantings for the project lots. Plantings are proposed around the storm water control ponds.

single-family dwellings (Vista Villa Phase 2) at 100 Club House Drive. PRD District

Preliminary site plan approval.

The Conservation Board noted and was pleased to see that the design plans show the wetland delineation and adjacent area and the flood plain delineation. This helped with the review by the conversation board.

The proposed street tree types and variety were noted. The Conservation board likes what is being proposed.
